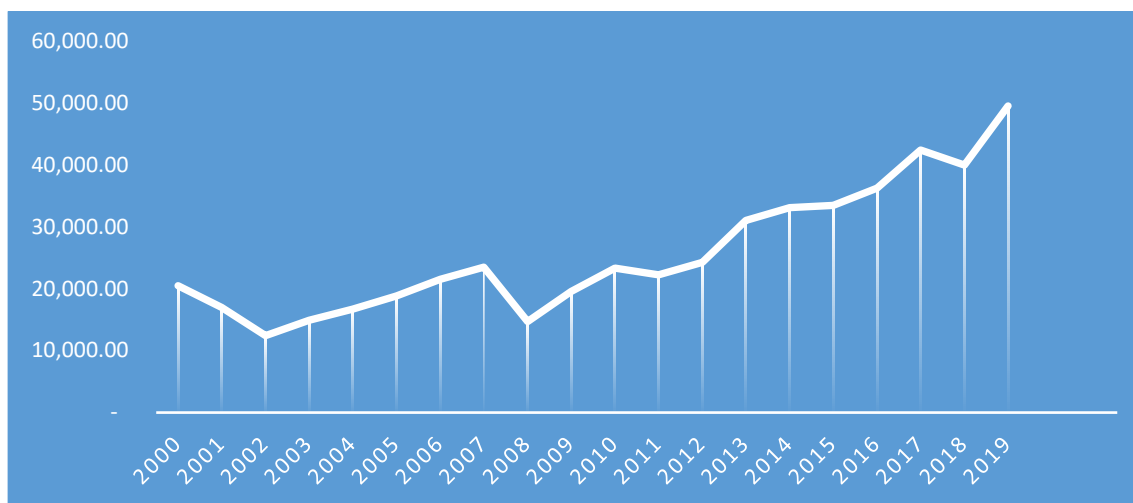
FUND STRATEGY

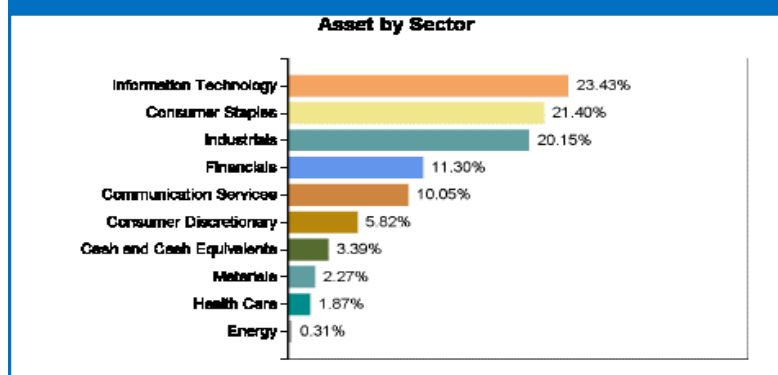

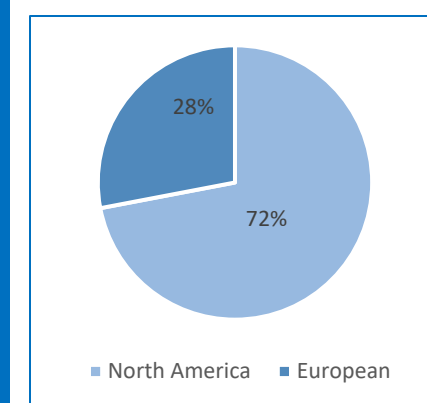

SECTOR ALLOCATION



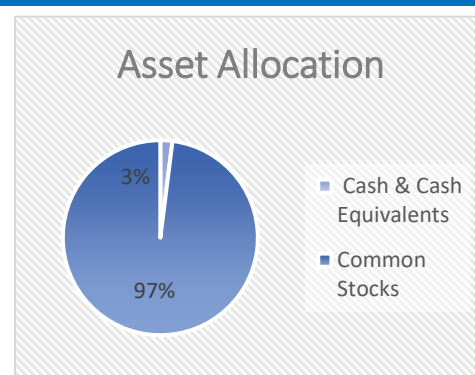
GEOGRAPHIC ALLOCATION
